6 7	The name of this nonprofit association shall be the Texas Congress of Parents and Teachers, commonly known as and referred to in these bylaws as the Texas PTA.			
8		ARTICLE II		
9		Purposes		
10	The purposes of Texas PTA shall be those of National PTA.			
11		Article III		
12		Basic Policies		
13	The basic policies of Texas PTA shall be those of National PTA.			
14		ARTICLE IV		
15		Membership and Dues		
16	Section	1.Members.		
17 18	A.	Membership in PTA shall be open without discrimination to anyone who believes in and supports the mission, purposes and policies of National PTA and Texas PTA.		
19 20 21	В.	The members of Texas PTA shall be the individual members of Local PTAs whose names are on file in the Texas PTA Office and for whom the national and state portion of dues have been paid as designated herein.		
22 23 24 25	C.	Members shall not have the right to vote on any corporate matters or have any of the statutory rights of "members" within the meaning of Chapter 9, Title 32, Tex. Rev. Civ. Stat., Non-Profit, Cooperative, Religious and Charitable Corporations, which governs non-profit corporations in the State of Texas, except as authorized by these bylaws.		
26	Section	2.Dues.		
27 28	A.	Annual dues for members shall include an amount for the Local PTA as determined by the Local PTA, state dues in the amount of \$2.25, and national dues as determined by National PTA.		

29	Section 3.Texas PTA Honorary Life Members.		
30 31 32	A. An honorary life membership may be granted to any deserving individual by a Local PTA, Council PTA, or Texas PTA upon the payment of a fee as determined by the Texas PTA Board of Directors.		
33 34	B. An honorary life membership does not authorize the right to vote or hold office without payment of the national and local portion of the dues.		
35 36	C. Each honorary life membership grants an exemption from paying the Texas PTA portion of the dues at only one Local PTA.		
37 38	ARTICLE V Constituent Divisions		
39 40	The constituent divisions of Texas PTA shall be the Local PTAs within the state of Texas and other divisions established by the Texas PTA Board of Directors.		
41 42 43	Section 1.Local PTAs. The Texas PTA Board of Directors shall determine procedures for the organization of Local PTAs and the Standards of Continuing Affiliation to include "good standing" requirements for Local PTAs.		
44 45	Section 2.Other Divisions. The Texas PTA Board of Directors may determine and set requirements for other divisions of Texas PTA.		
46 47	ARTICLE VI Officers		
48 49 50	Section 1.Officers. The officers of Texas PTA shall be president, president-elect, vice president field service, vice president leadership, vice president membership, vice president programs and resources, secretary, and treasurer.		
51 52	Section 2.Qualifications for President-Elect. To be eligible for the office of president-elect, a member must have served one term on the board of directors immediately before assuming office.		
53 54 55 56	Section 3.Term of Office. The officers shall assume office at the close of the annual meeting at which they are elected. These officers shall serve a term of two years or until their successors assume office. The vice presidents shall not serve more than two consecutive terms in the same office, and the other elected officers shall not serve more than one term in the same office.		
57 58 59 60 61	Section 4.Vacancy in Office. In the case of a vacancy in the office of president, the president-elect shall serve as president for the remainder of the term. A vacancy in any office other than president or president-elect shall be filled by an affirmative vote of a majority of the remaining members of the board of directors. The vacancy in the office of president-elect shall be filled at the next annual meeting by the voting body. In the interim, duties of the president-elect shall be delegated by the president.		
62 63 64	Section 5.Removal and Resignation of Officers . Any officer may be removed from office by the affirmative vote of two-thirds of the members of the board of directors then in office. Any officer may resign at any time by delivering a written resignation to the Texas PTA President and Secretary.		

65 66		6.Duties of Officers. The officers shall perform the duties as prescribed for the office in these
66	bylaws	, by the board of directors, in applicable state statutes, and in the parliamentary authority.
67	A.	Duties of the President. The president shall:
68		1. serve as the chair of the human resources committee;
69		2. appoint a parliamentarian;
70		3. appoint the chair of each standing committee and special committee, subject to the
71		approval of the board of directors, unless otherwise provided in these bylaws;
72		4. appoint the members of each standing committee and special committee unless otherwise
73		provided in these bylaws; and
74		5. appoint the Texas PTA representative to each meeting of the National PTA Council of States
75	В.	Duties of the President-Elect. The president-elect shall:
76		1. be the aide to the president;
77		2. serve as the chair of the advocacy committee and governance committee;
78		3. perform other duties as directed by the president; and
79		4. perform the duties of the president in the event the president is absent or temporarily
80		unable to execute the duties of the office.
81	C.	Duties of the Vice President Field Service. The vice president field service shall:
82		1. serve as the chair of the field service committee; and
83		2. perform other duties as directed by the president.
84	D.	Duties of the Vice President Leadership. The vice president leadership shall:
85		1. serve as the chair of the leadership committee; and
86		2. perform other duties as directed by the president.
87	E.	Duties of the Vice President Membership. The vice president membership shall:
88		1. serve as the chair of the membership committee; and
89		2. perform other duties as directed by the president.
90	F.	Duties of the Vice President Programs and Resources. The vice president programs and
91		resources shall:
92		1. serve as the chair of the programs and resources committee; and
93		2. perform other duties as directed by the president.
94	G.	Duties of the Secretary. The secretary shall:
95		1. record and maintain the minutes of all meetings of the members and the board of directors
96		2. send, or cause to be sent, notice of meetings of the members and of the board of directors;
97		3. have custody of the corporate seal;
98		4. affix the corporate seal on documents as authorized;
99		5. prepare an annual narrative history for approval by the board of directors; and
100		6. perform other duties as directed by the president.
101	Н.	Duties of the Treasurer. The treasurer shall:

1. serve as the chair of the budget and finance committee;

3. perform other duties as directed by the president.

2. make a financial report to the board of directors at each meeting; and

105 106	ARTICLE VII Directors-at-Large	
107 108 109 110	Section 1.Directors-at-Large. There shall be seven directors-at-large. Four elected directors-at-large shall be elected at the annual meeting in the even-numbered years, and three appointed directors-at-large shall be appointed by the president, subject to the approval of the board of directors, at the post-convention board of directors' meeting in even-numbered years.	
111 112 113 114 115	Section 2.Term of Office. The four elected directors-at-large shall assume office at the close of the annual meeting at which they are elected. The three appointed directors-at-large shall assume office immediately upon the approval of their appointments by the board of directors. The directors-at-large shall serve for a term of two years or until their successors assume office. The directors-at-large shall not serve more than two terms.	
116 117 118 119	Section 3.Vacancy in Office. A vacancy in the position of elected director-at-large shall be filled by an affirmative vote of a majority of the remaining members of the board of directors, and a vacancy in the position of appointed director-at-large shall be filled by appointment of the president subject to the approval of the board of directors.	
120 121 122 123	Section 4.Removal and Resignation of Directors-at-Large. Any director-at-large may be removed from office by the affirmative vote of two-thirds of the members of the board of directors then in office. Any director-at-large may resign at any time by delivering a written resignation to the Texas PTA President and Secretary.	
124 125 126	Section 5.Duties of Directors-at-Large. The directors-at-large shall perform the duties as prescribed for the office in these bylaws, by the board of directors, by the president, in applicable state statutes, and in the parliamentary authority.	
127 128	ARTICLE VIII Nominations and Elections	
129	Section 1.Nominating Committee.	
130 131 132 133 134 135	A. Composition. The nominating committee shall consist of five members, no more than two of whom may be from the board of directors. No two members of the nominating committee may be from the same geographic area of Texas PTA as defined by the board of directors. No person shall serve as a member of the nominating committee for two consecutive terms nor be eligible for election to the board of directors while serving on the committee. The president and president-elect shall not serve as members of this committee.	
136 137 138 139 140	B. Election of Members. The board of directors shall elect the members of the nominating committee by ballot at the meeting held between September 1 and November 1 in odd-numbered years. The election shall be by plurality vote. A vacancy on the nominating committee shall be filled by the nominee with the next greatest number of votes. The chair of the nominating committee shall be elected by the nominating committee.	
141 142 143 144 145	 C. Duties. The nominating committee: 1. shall consider all candidates for elected positions whose submissions meet the requirement set forth by the board of directors; 2. may consider additional candidates during its deliberations; and 3. shall submit only one name for each position to be filled. 	

146 D. Report of the Nominating Committee. The report of the nominating committee shall be posted 147 on the Texas PTA website no later than April 1 in even-numbered years and included in the notice of the annual meeting held in even-numbered years. The report of the nominating 148 149 committee shall be made at the annual meeting in even-numbered years following which 150 nominations from the floor may be made. 151 Section 2. Nominations from the Floor. Nominees from the floor shall give notice in writing to the Texas 152 PTA President in care of the Texas PTA Office no later than May 1 in even-numbered years. The names 153 of the nominees from the floor shall be included in the notice of the annual meeting held in even-154 numbered years. Section 3.Election of Officers and Directors-at-Large. With the exception of the president, officers and 155 156 elected directors-at-large shall be elected by ballot at the annual meeting in even-numbered years. If there is no more than one nominee for an elected position, the nominee shall be declared elected by 157 158 the President. 159 **ARTICLE IX** 160 Meetings 161 Section 1.Annual Meeting. Subject to proper notice, an annual meeting of the members shall be held in 162 July for the purpose of electing officers in even-numbered years, receiving the financial statement of 163 Texas PTA and other reports, considering legislative positions and resolutions as determined by the 164 Texas PTA Board of Directors, and transacting such other business as specified in these bylaws and as 165 may properly come before the annual meeting. 166 Section 2. Notice of the Annual Meeting. The notice of the annual meeting giving the place, date, and time of the annual meeting shall be provided at least 30 days but no more than 60 days in advance of 167 168 the annual meeting to each member of the Texas PTA Board of Directors, past Texas PTA presidents, the 169 presidents of each constituent division, and posted on the Texas PTA website. 170 Section 3. Voting Body. The voting body of the annual meeting of members shall be composed of the 171 following Texas PTA members who have registered as in attendance: 172 A. members of the Texas PTA Board of Directors; 173 B. past Texas PTA presidents; 174 C. Council PTA presidents or their alternates; 175 D. The president or their alternate from each Local PTA which has achieved Active Status by 176 December 1; and 177 E. delegates from each Local PTA which has achieved Active Status by December 1 or their 178 alternates as follows: 179 1. in addition to the Local PTA President, one delegate for up to the first 50 Local PTA 180 members accredited on the books of the Texas PTA Office as of December 1 prior to the 181 annual meeting; and 182 2. one additional delegate for each additional 50 Local PTA members or fraction thereof whose 183 names are on file in the Texas PTA Office as of December 1 prior to the annual meeting. 184 Section 4.Quorum. The quorum at the annual meeting shall be 150 voting delegates who have 185 registered as in attendance provided that a majority of the geographic areas of Texas PTA, as defined by

the board of directors, is represented.

Section 5.Voting. No delegate shall vote in more than one capacity.

188 Section 6.Special Meetings. A special meeting of the members shall be called upon a two-thirds vote of 189 the Texas PTA Board of Directors with a notice giving the place, date, time and purpose of the special 190 meeting. The notice of a special meeting of the members shall be mailed to the Texas PTA Board of 191 Directors, past Texas PTA presidents and presidents of constituent divisions at least 30 days but no more 192 than 60 days prior to the meeting. The notice of a special meeting shall also be posted on the Texas PTA 193 website at least 30 days but no more than 60 days prior to the meeting. The voting body at a special 194 meeting of the members shall be those Texas PTA members who have registered as in attendance. A 195 quorum at a special meeting of the members shall be 150 members provided that a majority of the 196 geographic areas of Texas PTA, as defined by the board of directors, is represented. 197 **ARTICLE X** 198 **Electronic Meetings** 199 Section 1. The Texas PTA Board of Directors is authorized to meet by telephone conference call or 200 through other electronic communications media so long as the meeting has been properly noticed in 201 accordance with these bylaws and all the members may simultaneously hear each other and participate 202 during the meeting. 203 Section 2. The board of directors may vote by postal or electronic mail between meetings. Any 204 action required or permitted to be taken at any meeting of the board of directors may be taken 205 without a meeting if a written consent, setting forth the action so taken, is signed by all the 206 members of the board of directors and such written consent shall have the same force and 207 effect as a unanimous vote at a meeting of the board of directors. 208 ARTICLE XI 209 **Board of Directors** 210 Section 1.Composition. The members of the board of directors shall be the officers and the directors-211 at-large. 212 Section 2. Eligibility. Eligibility requirements of directors shall be an individual who: 213 A. subscribes to, believes in and supports the mission, purposes and policies of National PTA and 214 Texas PTA; 215 B. agrees to join the association promptly, if not a current member at the time of election or 216 appointment; C. receives no compensation or honoraria from the association except reimbursement for 217 218 reasonable expenses as set forth in Texas PTA policies and procedures; 219 D. has no financial interest, direct or indirect, in any transaction made by the association without 220 the approval of the board of directors; 221 E. has met the criteria or is committed to meeting the criteria of service as established by the 222 board of directors; 223 F. neither holds nor announces candidacy to any elected public office; 224 G. has not served more than 15 years on the board of directors; and 225 H. has not served as Texas PTA president.

Section 3.Power and Authority of the Texas PTA Board of Directors. The business and affairs of the association shall be managed by or under the direction of the Texas PTA Board of Directors, which may exercise all the powers of the association, subject to the restrictions imposed by law, the Articles of Incorporation or these bylaws.

Section 4. Meetings.

- A. **Regular Meeting.** Two regular meetings of the board of directors shall be held in each calendar year, one in conjunction with the annual meeting and one between September 1 and November 1. One additional regular meeting of the board of directors may be held each year at a time and place as called by the president or five members of the board of directors with notice given in writing, including electronic mail, at least 30 days but not more than 60 days before the meeting to each member of the board of directors. Notice may be waived by the members of the board of directors as provided by law.
- B. **Special Meetings.** Special meetings of the board of directors may be called by the president or five members of the board of directors with notice given in writing, including electronic mail, at least three days before the meeting to each member of the board of directors. Notice may be waived by the members of the board of directors as provided by law.
- C. Quorum. A majority of the members of the board of directors shall constitute a quorum.
- **Section 5.Notice.** Notice shall be in writing (including electronic mail, facsimile, or other means of immediate communication, etc.) and shall be deemed given at the time when the same is personally delivered, or delivered to a common carrier for overnight or next business day delivery, but notice shall also be deemed given seven days after it is deposited in the United States Postal Service with first class postage thereon prepaid. All such notices shall be directed to the director's address, facsimile number or email address as shown on the records of the association. A waiver of notice in writing, signed by the person or persons entitled to such notice and filed with the records of the meeting, whether before or after the holding thereof, shall be equivalent to the giving of such notice. Presence at any meeting without objection also shall constitute waiver of any required notice.
- Section 6.Vacancy. Vacancies occurring as a result of the resignation, death or removal of a director shall be filled by an affirmative vote of a majority of the remaining members of the board of directors unless otherwise provided in these bylaws.
- Section 7.Removal and Resignation of Director. Any director may be removed from office by the affirmative vote of two-thirds of the members of the board of directors then in office. Any director may resign at any time by delivering a written resignation to the Texas PTA President and Secretary.

258 ARTICLE XII 259 Committees

Section 1.Standing Committees.

- A. The standing committees of Texas PTA shall be advocacy, audit, budget and finance, field service, governance, human resources, leadership, membership, and programs and resources.
- B. All standing committee chairs shall report to the board of directors and shall be responsible to the president between meetings of the board.

- 265 C. The president and president-elect shall be an ex-officio member of all committees except the
 266 audit committee, nominating committee and any committees they chair as provided in the
 267 bylaws. The chair of each standing committee shall be ex-officio a member of all
 268 subcommittees within the respective committee.
 - D. Committees may include non-members of Texas PTA so long as at least two committee members are members of the Texas PTA Board of Directors, unless otherwise provided in these bylaws.
 - E. The term for committee members, except for the nominating committee, shall correspond to that of the officers.

Section 2. Duties of Committees.

A. **Advocacy Committee.** The committee shall:

- 1. consist of the president-elect, who shall serve as the chair, and at least four additional members; and
- 2. review the advocacy program of Texas PTA and make recommendations concerning the program to the board of directors.

B. Audit Committee. The committee shall:

- 1. consist of at least three and no more than five members of the board of directors, none of whom shall be officers and each of whom shall be both independent and financially literate;
- 2. review significant accounting and reporting issues with the board of directors;
- 3. have general oversight responsibilities for:
 - a. the financial reporting process;
 - b. risk management;
 - c. internal and, when applicable, external audit processes including engagement of any external auditing firm;
 - d. processes for monitoring compliance with laws, regulations and the association's ethics and conflict of interest policies;
 - e. any special investigations for noncompliance thereof; and
 - f. audit committee management and reporting responsibilities.

C. Budget and Finance Committee. The committee shall:

- 1. consist of the treasurer, who shall serve as the chair; the president-elect; and three additional members of the board of directors;
- 2. present an annual budget to the board of directors for its approval; and
- 3. make financial decisions between meetings of the board of directors as necessary.

D. Field Service Committee. The committee shall:

- 1. consist of the vice president field service, who shall serve as the chair, and at least 20 members; and
- 2. support, guide, train and communicate with Texas PTA's constituent divisions.

302	E.	Governance Committee. The committee shall:
303		1. consist of the president-elect, who shall serve as chair, and at least three members of the
304		board of directors;
305		2. review periodically the governance of Texas PTA, including documents related to the
306		association's governance and structure, to ensure the association's efficiency and
307		accountability to its purposes;
308		3. in collaboration with the field service and membership committees, determine procedures
309		for organization, affiliation, and dissolution of PTAs;
310 311		4. review and make recommendations regarding amendments to these bylaws to the board of directors; and
312 313		review and make recommendations regarding amendments to bylaws for constituent divisions to the board of directors.
314 315	F.	Human Resources Committee. The committee shall: 1. consist of the president, who shall serve as the chair, the president-elect, and three
316		additional members of the board of directors; and
317		2. review, revise and approve changes to the:
318		a. human resources manual;
319		b. employee organizational chart; and
320		c. employee benefit and retirement plans; and
321		3. conduct annual performance review of the executive director; and
322		4. determine salary of executive director and approve salary ranges for other employees.
323	G.	Leadership Committee. The committee shall:
324		1. consist of the vice president leadership, who shall serve as the chair, and at least six
325		additional members; and
326 327		coordinate and develop training strategies, evaluate effectiveness of leadership development practices, and identify potential leaders.
328	Н.	Membership Committee. The committee shall:
329 330		1. consist of the vice president membership, who shall serve as the chair, and at least four additional members;
331 332		2. develop and promote membership strategies and evaluate effectiveness of membership development practices.
333	I.	Programs and Resources Committee. The committee shall:
334		1. consist of the vice president programs and resources, who shall serve as the chair, and at
335		least four additional members;
336		2. review all adult and student programs offered or supported by Texas PTA; and
337		3. make necessary recommendations to sustain and expand such programs.

Section 3.Special Committees. Special committees may be created by the president or by the board of

directors.

340 **ARTICLE XIII** 341 Indemnification 342 Unless expressly prohibited by law, the association shall indemnify any person made, or threatened to 343 be made, a party to an action, suit or proceeding (whether civil, criminal, administrative or 344 investigative), whether such is an action by or in the right of the association or otherwise, by reason of 345 the fact that such person is or was a director, officer, employee or agent of the association or serves or 346 served any other enterprise at the request of the association (all of such persons being sometimes 347 referred to in this Article Fifteen as a "corporate functionary"), against all expenses (including attorneys' 348 fees), judgments, fines and amounts paid in settlement actually and reasonably incurred by such person 349 in connection with such action, suit or proceeding, provided such person acted in good faith and in a 350 manner he or she reasonably believed to be in or not opposed to the best interests of the association 351 and, with respect to any criminal action or proceeding, had no reasonable cause to believe his/her 352 conduct was unlawful, except that no indemnification shall be made in relation to matters as to which 353 such person shall have been finally adjudged in such action, suit or proceeding to be liable to the 354 association. 355 Any indemnification under this Article shall be made by the association only as authorized in the specific 356 case upon a determination that indemnification of the corporate functionary is proper in the 357 circumstances because he or she has met the applicable standard of conduct set forth in this Article. 358 Such determination shall be made by the Texas PTA Board of Directors by a majority vote of all 359 disinterested directors. 360 The rights of indemnification provided for in this Article shall be in addition to all rights to which any 361 corporate functionary may be entitled under any agreement or as a matter of law or otherwise, and 362 shall inure to the benefit of the corporate functionary's estate, heirs, executors and administrators. If 363 this Article or any portion hereof shall be invalidated on any ground by a court of competent jurisdiction, 364 the association shall nevertheless indemnify each corporate functionary to the full extent permitted by 365 any applicable portion of this Article that shall not have been invalidated. 366 The association may purchase and maintain insurance on behalf of any corporate functionary against 367 any liability asserted against him/her and incurred by him/her in any such capacity or arising out of 368 his/her status as such, whether or not the association would have the power to indemnify him/her 369 against such liability under the provisions of this Article. 370 **ARTICLE XIV** 371 **Parliamentary Authority** 372 The rules contained in the current edition of Robert's Rules of Order Newly Revised shall govern Texas 373 PTA in all cases to which they are applicable and in which they are not inconsistent with these bylaws, 374 the Articles of Incorporation, and any other rules adopted by Texas PTA.

375 ARTICLE XV 376 **Amendment of Bylaws** 377 Section 1.Submission of Amendments. 378 A. Amendments to the bylaws may be submitted by the Texas PTA Board of Directors, a standing 379 or special committee of Texas PTA, or a constituent division or its board of directors. 380 B. Amendments to be considered at an annual meeting shall be submitted to the Texas PTA 381 Governance Committee on or before the stated deadline, with the exception of the Texas PTA 382 Board of Directors, who may propose amendments at any time provided that the requirement 383 for notice has been met. 384 1. The deadline for amendments to be considered at an annual meeting to be held in an 385 even-numbered year is August 1 preceding the annual meeting at which they will be 386 considered. 387 2. The deadline for amendments to be considered at an annual meeting to be held in an 388 odd-numbered year is January 1 preceding the annual meeting at which they will be 389 considered. 390 C. Amendments to be considered at a special meeting of the members shall be submitted to the 391 Texas PTA Governance Committee at least 45 days preceding the special meeting at which they will be considered, with the exception of the Texas PTA Board of Directors, who may propose 392 393 amendments at any time provided that the requirement for notice has been met. 394 Section 2.Notice. Amendments to the bylaws shall be posted on the Texas PTA website no later than 30 395 days preceding the opening of the meeting of members at which they are to be considered and shall be 396 included in the notice of such meeting of members. 397 Section 3. Vote Required. The bylaws may be amended by the voting body at an annual meeting or a 398 special meeting of the members by a two-thirds vote provided that notice as described in Section 2 has 399 been given and that the amendments have been approved by the Texas PTA Board of Directors. 400 Adopted bylaw amendments shall be posted on the Texas PTA website no later than 30 days following 401 the adjournment of the meeting at which they were adopted. 402
