

## **National PTA Reflections® Program Official Participation Rules**



By entering the "National PTA Reflections Program," entrants accept and agree to be bound by these Official Rules as well as the entry requirements for their specific arts category and division. Any violation of these rules may, at the PTA's discretion, result in disqualification. (The "PTA" referred to in these rules includes all PTAs reviewing the entry.) All decisions of the reviewers regarding this program are final and binding in all respects.

Student Eligibility: The Reflections program is open to all Texas students who meet the necessary requirements:

## Schools Supported by a Local PTA/PTSA

- Students must attend a school with a Local PTA/PTSA which attains Active Status<sup>1</sup> no later than October 31; or students must attend a school which is defined within the service area of a community-based Local PTA/PTSA which attains Active Status¹ no later than October 31.
- The student or at least one person from their primary household must be a current member<sup>2</sup> of the Local PTA/PTSA where the student is participating. Each Local PTA/PTSA may determine a date by which the member must join.
- Active Status requirements are stipulated as part of the Texas PTA Standards of Continuing Affiliation.
- The Local PTA membership year is August 1 July 31 each year.

## Home-School Families, Virtual Schools and Non-PTA Schools

- Students who attend a school that is not supported by a Local PTA/PTSA may participate through the Lone Star Statewide PTA<sup>1</sup>, as long as the student or at least one person of their primary household is a member of this PTA no later than October 31. Joining is easy at www.joinpta.org2.
- Students who attend a school that is supported by a PTA/PTSA are not eligible to participate through the Lone Star Statewide PTA.
- When joining Lone Star Statewide PTA, select Statewide ISD as the district.

National PTA Reflections® 2025-2026 Theme: I Belong. Only new pieces of artwork inspired by the current theme will be accepted.

**Grade Divisions:** Students may enter the Reflections® program in the appropriate division for their grade.

**Primary:** Preschool – Grade 2 Middle School: Grades 6-8 Intermediate: Grades 3-5 **High School:** Grades 9-12

Accessible Arts: All grades welcome (please refer to the Accessible Arts rules)

If students do not fall under specific grade divisions, National PTA suggests they be grouped by age (Primary: Up to age 7; Intermediate: Ages 8-10; Middle School: Ages 11-13; High School: Ages 14+).

Arts Categories: There are six arts categories – dance choreography, film production, literature, music composition, photography and 2D visual arts. Students may enter the Reflections program in one or more arts categories with no limit to the number of entries in a single category. See each arts category's rules for additional entry requirements.

Entry Requirements: (All participants must also follow arts category rules)

- Student Entry Process: The student entry form must be completed with signatures and all contact information requested. Local PTA Reflections chair information must be entered where requested.
- All entries must include a title and an artist statement. The artist statement communicates what inspired the work, how it relates to the theme, and the content of the work. The statement must include 10-100 words.
- Each entry must be the original work of one student only. An adult may not alter the creative integrity of a student's work. Because the program is designed to encourage and recognize each student's individual creativity, help from an adult or collaboration with other students is not allowed except in the Accessible Arts Division. Other individuals may appear in or perform a student's work, but the work itself must be the creative product of one student only. See the specific arts category rules and Accessible Arts division rules
- Use of copyrighted material is prohibited, except for recorded music in dance and film entries. Background music must be cited on the student entry form. Plagiarized entries will be disqualified. Plagiarism is defined as using another person's ideas, writings, or inventions as one's own. Use of PowerPoint templates and generative elements (e.g., algorithmic techniques, artificial intelligence) is prohibited. Entries may include portions of copyrighted works; photos, printed type or digital media clippings, as long as those portions are used to create a new and different work of art.
- Digital technology and/or software can be used to develop, enhance, and/or present an entry, but may not provide the primary design and/or concept. Entrants must use the "Additional Details" field to provide a brief description of the tools and method used in the creation process, including any generative elements (10 to 50 words).

FINALIST SELECTION AND NOTIFICATION: Entries are reviewed at the local, council, state, and national levels. Each PTA determines its own judges for the program. Entries will be judged primarily on how well the student uses his or her artistic vision to portray the theme, originality, and creativity. The National PTA Reflections® program makes no restrictions on content or subject matter in artwork. Under no condition may parents or students contact the judges to dispute the status of any entry. Awards are announced at each level of judging at the Coordinator's discretion. Texas PTA award results will be posted on the Texas PTA website in March. National award recipients are notified via email by National PTA in May. Each PTA in its sole discretion, will select finalists for exhibition and provide awards.

Ownership and License: Ownership in any submission shall remain the property of the entrant, but entry into this program constitutes the entrant's irrevocable permission and consent that PTA may display, copy, reproduce, enhance, print, sublicense, publish, distribute, and create derivative works for PTA purposes. PTA is not responsible for lost or damaged entries. Submission of entry into the PTA Reflections program constitutes acceptance of all rules and conditions.

PARTICIPATING ENTITIES: This program is administered by the National Parent Teacher Association (PTA) and PTA affiliates. Parent groups not affiliated with National PTA are not eligible to sponsor this program.
